It was formed for the purpose of promoting the conservation of gamefish and encouraging visitors to fish in Martin County waters. To this day, they remain our primary goals. In addition, the Club has a Scholarship Program, which offers three scholarships each year to graduating seniors from the local high schools who are entering the field of Marine Sciences.
